PLEASE NOTE: All applications for 'Function Room Hire' will require a security deposit of £50.00 to secure your booking.

3. The Club will, at all times, provide a doorman to ensure the privacy of such functions, and the Hirer must contact the Club Secretary for this said purpose.
4. All cancellations must be notified to the Club Secretary in writing and will incur a non refundable £50.00 fee.
5. A list of guests attending the function with full names **MUST** be lodged with the Club Secretary at least twenty – eight days prior to the function. Those persons will become **TEMPORARY MEMBERS**, with full member rights for the day of the function.

The Management Committee reserves the rights of admission at all times.

6. Self catering is permitted and **MUST** be accompanied by a signed waiver.
7. Party poppers, sparklers, etc are not permitted on the premises.
8. All functions, including music, **MUST** finish no later than 10 minutes after the bar closes.
9. All drinks **MUST** be consumed no later than 20 minutes after the bar closes.
10. The Club will not be held responsible for any theft or damage incurred within the Club or the Club carpark.
